## GREATER LYNN INTERNATIONAL COLOR DUAL PROJECTION EXHIBITION

**YOU ARE INVITED** - The Greater Lynn Photographic Association invites all photographers everywhere to submit color slides or digital images to the GREATER LYNN INTERNATIONAL COLOR DUAL PROJECTION EXHIBITION. All phases of the exhibition will be conducted in accordance with the recommended practices of the Photographic Society of America, the Federation Internationale de l'Art Photographique 2007/019, the Canadian Association for Photographic Art, and Interessengemeinschaft Internationaler Wettbewerbs-Fotografen (IIWF) 2007/03.

**CONDITIONS OF ENTRY** - You may enter either slides or digital images, but not both.

Report cards will be sent to each entrant within 5 days after the judging. **Our acceptance rate is normally 30-35%.** A catalog will be sent to all entrants. If you wish to have your slides forwarded to another exhibition in the U.S., fill in the name and address of that exhibition on the return label provided.

Two PSA Gold Medals will be awarded by the judges for the "Best of Show" and "Best Creative" slides or digital image. Creative photography may be defined as "altered reality." It **is not** necessary to mark entries for consideration for this award.

Entries must originate as photographs (image/captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright by the entrant. Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates. All final work must be on photographic film or on electronic file.

Once an image has been accepted in Greater Lynn, that same image, or a like "in camera" or a reproduction duplicate of that image may not be re-entered in the same format in the same section in that exhibition regardless of its title. Nor may it be re-titled for resubmission in Greater Lynn or another PSA recognized exhibition.

The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to exhibition rules and conditions.

**SLIDES:** There is no restriction on subject matter. A total of four (4) slides, **exposed by the entrant**, may be submitted in 2" x 2" mounts only. Ready mounts (cardboard, plastic or glassbound mounts) are acceptable.

Slides must be clearly marked with the title, projection sequence number (1, 2, 3, 4), maker's name and address, and must be spotted in the lower left hand corner as viewed normally. All possible care of your slides will be taken, but no responsibility will be assumed for any loss or damage during the Salon or in transit.

**DIGITAL:** Digital entrants must fill out the entry form. **Image files must be submitted on CD. No email submissions will be accepted.** See backside of entry form for instructions on preparing images for digital submissions.

**NAMING YOUR IMAGES:** Image file names should include the maker's name and projection sequence number (1, 2, 3, 4) (surname\_firstname\_image #). The corresponding number on the entry form should contain the title of the image. For example, your four submissions on a CD may look like this:

**An entrant's four images will be distributed throughout four rounds of judging.**

**Note:** GLPA takes great pride in reproducing a high quality **COLOR CATALOG** approximately 60 pages long with the over 32 color reproductions. All medal winning slides or images are reproduced in the catalog without removing the slide from the mount. Therefore, slides/images with no reproduction rights will **not be eligible for medals.**

**FIAP MEDALS:** The Federation Internationale de l'Art Photographique has granted permission to award Gold, Silver, and Bronze FIAP Medals plus six Honorable Mention Ribbons.

**CAPA MEDAL:** The Canadian Association for Photographic Art Gold Medal will be awarded to the highest aggregate score achieved by an entrant.

**IWF MEDAL:** Interessengemeinschaft Internationaler Wettbewerbs-Fotografen (IWF) medal will be awarded to the highest scoring slide or image not winning another award.

**ALFRED JENDROSZEK MEDAL:** President of IWF is donating a medal to be awarded to the highest scoring slide or image from a foreign entry not winning another award.

**DAVID HUGHES MEMORIAL MEDAL:** This medal will be awarded to the maker of the best "abstract" slide or image. *Abstract photography may be defined as an image expressing a quality apart from the usual literal photographic depiction.*

**CLUB MEDAL AWARD:** Highest aggregate score of a club. The club's top seven entrants total scores will be counted toward the club's total score. Slides and digital entries must arrive in the same packet.

**GREATER LYNN AWARDS:** Honor Award Ribbons will go to approximately 10% of the highest scoring slides or image. All 12 category GLPA Medals will be reserved for non-GLPAers only and any GLPA member who becomes eligible for one of these awards will receive a Special Medal. **Our GLPA Gold Medals are mounted on a thick walnut stained wood block with a gold colored plate inscribed with the medal category, year, winner's name and slide or image title.**

**DIGITAL IMAGES ACCEPTED ON CD ONLY. NO EMAIL SUBMISSIONS.**

**PREPARING IMAGES FOR ENTRY:** The projector is set for 1024 x 768 pixels. Your image dimensions should be within these numbers but does not necessarily need to match this ratio. Normally, you will set the width at 1024 for horizontal images, and set the height at 768 for vertical images. By using the "Constrain Proportions" option, you only need to set one dimension, and your image editing software will make the appropriate setting for the other dimension, and it may not be the number indicated here. For example, you may set your width to 1024, and using "Constrain Proportions," the height dimension may be set at 681. This will project correctly. Resolution should be set at 200 for purposes of reproduction in our color catalog. Do not compress files.

**NAMING YOUR IMAGES:** Please use your name in the file names, as well as the projection sequence number (surname\_firstname\_seq #). For example, your four submissions on a CD may look like this:
